

# Caddo-Shreveport Narcotics Unit conducts "Operation May Day."

On May 9, 2014, the Caddo-Shreveport Narcotics Task Force, with the assistance from task forces with the DEA, ATF and U.S. Marshal wrapped up an investigation named "Operation May Day."

The week long operation resulted in the execution of 7 search warrants, 3 follow-up investigations, 15 felony arrests, and 6 misdemeanor arrests. Agents also seized illegal narcotics with a street value of \$148,625.00, 10 firearms and \$17,103.00 in cash.
