

# Task Force arrests ten in warrant round up

Thursday, August 6, 2020

The Caddo-Shreveport Narcotics Task Force agents arrested ten people during a four-day operation that wrapped up on Thursday, said Caddo Sheriff Steve Prator and Shreveport Police Chief Ben Raymond.

Agents seized seven firearms, a bullet proof vest, a gas mask, 30 ml of liquid steroids (\$300 street value), 836 grams of THC edibles (\$8,360 street value), 179 grams of crack cocaine (\$17,900 street value), 111 grams of powder cocaine (\$11,100 street value), 779.6 grams of methamphetamines (\$77,960 street value), 85 grams of marijuana (\$850 street value), and \$5,256.00 in cash.

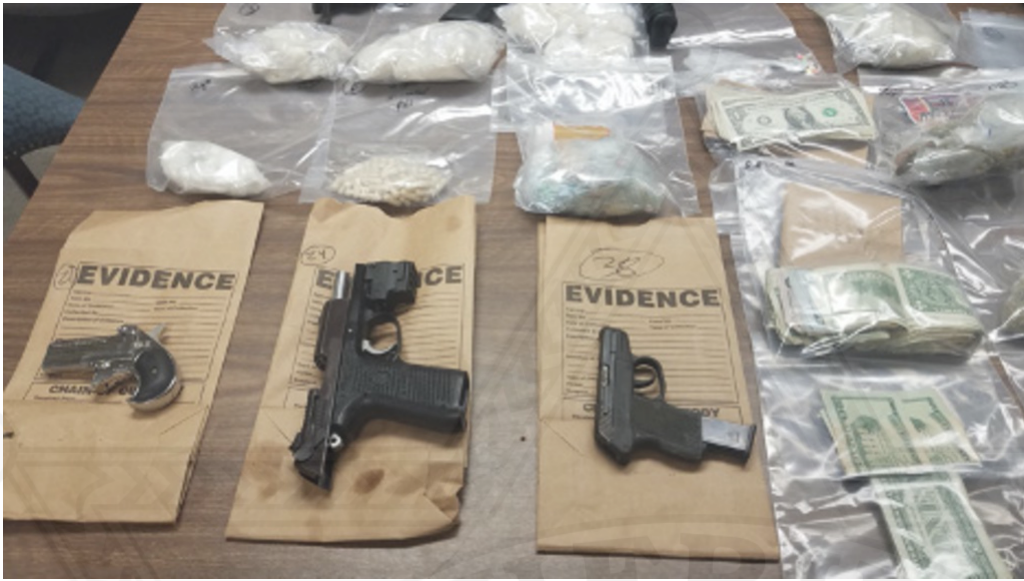
